CONTRACT OF LAW REVIEW

Bode visited the county commissioners meeting last week and spoke with them about the contract of law. Bode made a new formula and proposal of the contract pricing that included population and came to the price of \$77,971. He let the council know his counter proposal was rejected by the commissioners. But the commissioners are looking at capping the increase on yearly contract of law amounts. Bode's suggestion to the council is to go with the current contract for the first 3 months and see what changes happen with an extra deputy and see if there can be more discussion and see if the county commissioners and city can come to a conclusion with the contract and capping increases. Gayle Van Genderen commended Bode for the work he did and the meeting with the commissioners.

Bode made a motion to approve the 2024 contract law agreement with Aurora County, committing to the first three months of funding with a 60-day evaluation. All voted aye. No opposed. Motion not carried, as there was no second. This matter will be revoted during the January 8th meeting to carry on with the motion. The no second of the motion was not determined until after the meeting.

COLA (COST OF LIVING ADJUSTMENT) FOR CITY EMPLOYEES

The council has tabled this until the January 8th meeting.

GWORKS

Cindy Geiman, Deputy Finance Officer, explained to the council that the new HR Hub is installed in the computer, some tweaking does need to be done, for everything to be implemented correctly. There will be more training on this on January 3rd, 2024.

PICKUP FLATBED

Mayor Kehn asked the council to entertain the idea of replacing the flatbed on the White Ford pickup as it is rusted. The council agreed to entertain getting pricing for a new flatbed for the pickup. Supt. Darin Cranny will bring pricing to the January 8th meeting.
